Disability Rights Arizona (DRAZ) and its partners are excited to announce the 13th Annual African American Conference on Disabilities (AACD) will be held in-person on June 28, 2024. The AACD is a premiere comprehensive disability conference in the United States that addresses the intersection between race and disability. The conference examines avenues for self-advocacy to ensure the effective provision of services, resources, and enforcement of civil rights in the African American and disability communities.

Virtual pre-conference
